In developing this plan, ILA has meaningfully engaged all staff, students, parents, the board, and the public through surveys, a public meeting (11/29/2021). Additionally, teacher and staff input regarding the needs of our students was collected throughout the school year and during a dedicated LCAP input meeting held with all staff members on April 21st, 2021. Additional parent and family input was collected during coffee with the principal meetings, parental input meetings held on April 29th and 30th, 2021; one-on one conferences, and our recent ESSER parent survey.

Teachers and staff provided most of the suggestions based upon student learning outcomes as measured on our beginning of the year iReady assessments and observations of student behaviors/needs. These initial targeted expenditures to address learning losses were affirmed by our parents as needed. ILA parents also added that they would like to see our student have access to

afterschool tutoring, more sports, meditation/calming activities, and more opportunities for parental involvement. During the parental input meeting, parents also stated they would like to have summer and spring learning camps.

The Parent meetings were held via Zoom, and every current parent and enrolling parent was sent a text message reminder of the Zoom meeting with the necessary link to participate. Additionally, invitations to the parent meetings and surveys were hand delivered to all our attending families. Collectively, stakeholders want to see supports in place that assist all our students growing academically, being safe, and having access to a well-rounded education that is not exclusively focused on reading, writing, and arithmetic.

Staff and board members also suggested that highly structured classrooms focused on the California Standards, more parental involvement, tutoring, social emotional support, parent workshops, and addressing misbehavior in the classroom would be helpful for our students.

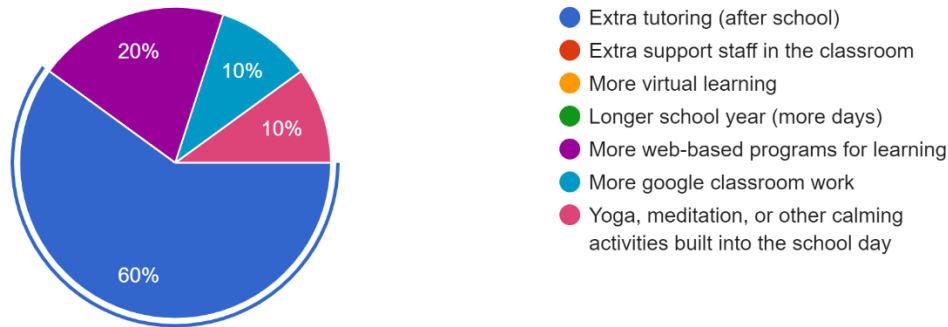


What do our children need addressed most since the COVID Lockdowns and lost learning time

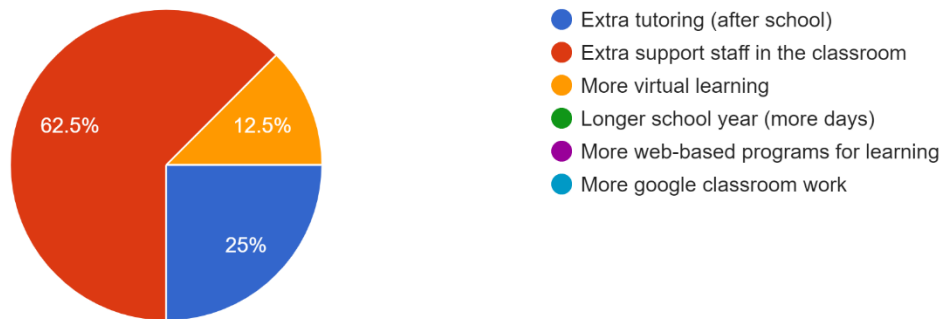
What would be the best way to help your child recover from the COVID learning loss

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;

- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
